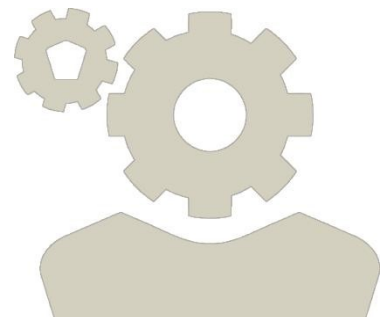

## **Recognition of Prior Learning (RPL)**

RPL stands for recognition of prior learning. It is the acknowledgement of a person's skills and knowledge acquired through previous training, work or life experience. A qualification gained in this way is identical to a qualification gained from traditional studying. There is no coursework or study, you just submit the documents you have created and use in the workplace.

### **The main RPL requirement:**

This is a brief checklist of the terms and requirement for CHC51015 - Diploma of Counselling

An applicant must be at least 20 years old to be eligible to obtain this Diploma and has a minimum of two years of work experience and/or related studies.

- **A detailed resume (CV):** The CV must be stating the company/work name, address, of the work or institute, the years of employment or study, role and any work experiences related to the specific Diploma the applicant is applying for.

- **An employment letter** (employment reference letter): This letter must state the role of the employee, employment date (start – end or if still employed) as well as the full company/work name, address and contact details. An assessor may contact the employer; this will happen in case there is no sufficient or enough information stated in the employment letter. However, the assessor will advise the applicant before contacting the employer for privacy reasons.

- **Any certifications or degrees previously awarded** (this is optional)

**NOTE:** All documents must be in English or translated professionally to English

## **Decline and disapproval of an RPL application**

In some cases, an application may get declined due to insufficient documentations or experience. However, the assigned assessor may advise the applicant to enroll in a short online course to fill out experience needed for the applicant to be eligible to be awarded with the qualification. The assessor will be in contact with the applicant discussing whatever is needed and to facilitate the process (at this point no payment is made). The payment is made only after the application is approved to be submitted.

**NOTE:** Additional surcharge would apply if the applicant needs to enroll in a short online course. The fees of the short online course is not included in the diploma application fees. Usually the short online courses fees will not cost over \$400 and the whole course can be completed within few days. This is not a common case though it's possible.

## **Online Study and Fast-Track Training**

All our online courses are delivered through the latest technologies and learning management systems which in return makes the online learning experience very simple, enjoyable and user-friendly.

Our Fast-Track training and workshops are designed to cover everything necessary and required to obtain the qualification in a short time and sometime by combining online subjects (depending on the course) and by compounding the information delivered during the live training. Our Live training is designed to create an amazing encouraging experience for our students to build their confidence to become the best at what they do.

## Posting and receiving the diploma

During our Fast-Track training and workshops, the qualification is handed to the students with a simple graduation ceremony. Furthermore, for RPL and online courses, The MindTech Institute usually posts the qualification and the related documents in a package through AustPost Express, DHL and other express courier companies with a tracking number will be also emailed to the student.

No additional charges will apply on postage since the MindTech Institute pays the postage fees – that means the applicant should not pay any fees upon receiving the package. ## Upon completion

Once an applicant has been awarded with a diploma, The MindTech Institute will post (express mail) the original copy of the certificate along with the student number and a unique certificate identification code. These numbers are used to authenticate and verify the certificates. This is available for any public or private organization/corporation or institution including immigration to authenticate the validity of diplomas whether for employment, higher education, study abroad and other immigration purposes by contacting the institute as well as through other protocols used between institutes and universities.

## Course duration

**RPL:** Recognition of Prior Learning RPL process takes between 2 – 3 weeks after the application has been submitted along with all the requirements.

**Fast-Track:** is for those who already have knowledge or experience in this field can join our accelerated training class generally held in Sydney. For more information, please check our website EVENT page.

**Online:** The completion timeframe for this qualification is estimated twelve (12) months, and can be completed even sooner depending on the time spent on the course. Learners who are granted course credit (Credit Transfer (CT) and/or Recognition of Prior Learning (RPL) will receive a revised duration once their credit has been processed by Student Services.

## FEES AND METHODS OF PAYMENTS

Fees for the Diploma of Counselling: **RPL \$2990 | Fast-Track \$3990 | Online Study \$4990**. These fees also include the Australian taxes. The full amount should be paid once our assessors approve the application. No certificate would be issued and sent before the full amount has been paid as direct money transfer or through debit/credit cards. An automated receipt will be sent by an email once a payment is made and an official receipt with the full amount paid will be posted to the applicant along with the qualification and transcript/s.

NOTE: Please contact us if our method of payment isn't available in your country.

## Registration & Payments

Enrollment becomes effective upon receipt and full amount is paid unless choosing “Pay Deposit” which is an easy payment option. This option will allow you to only pay half of the fees amount (50%) and get certified once the remaining balance is paid. NOTE: additional fees will be applied if short courses are needed.

The fees are in Australian Dollar if you live in Australia. Any other country the fees are in USD.
